Tribal Lands Bidding Credits

- Credits given to winning bidders in Commission spectrum auctions who deploy facilities on and provide services to qualifying tribal lands.
- A qualifying tribal land is any federally recognized tribal area that has a wireline telephone penetration rate equal to or less than 85 percent.
- See 47 C.F.R. 1.2110(f)(3)(i)

Method of Calculation

- The Commission awards:
 - \$500,000 for the first 200 square miles (518 square kilometers) of qualifying tribal land; and
 - \$2500 for each additional square mile (2.59 square kilometers).
 - See 47 C.F.R 1.2110(f)(3)(iii)

Bidding Credit Limit

- Maximum limit placed on credits.
- For gross bid amounts of \$1 million or less, the cap will be 50 percent of the gross bid.
- For gross bid amounts of greater than \$1 million, but less than or equal to \$2 million, the cap will be \$500,000.
- For gross bid amounts exceeding \$2 million, the cap will be 35 percent of the gross bid
- See 47 C.F.R. 1.2110(f)(3)(iv)

Increased Bidding Credit

- In the *First Report and Order* of the tribal lands bidding credit proceeding, the Commission stated it would consider a waiver request for a higher bidding credit where an applicant shows that its infrastructure costs exceed the available credit under the formula .
 - Such a waiver request is subject to the percentage cap; Commission will not grant a waiver in excess of the cap.
 - Applicant must make a detailed showing of their projected infrastructure costs, including certification by an independent auditor that the estimated costs are reasonable.
 - No license grant for any market for which a waiver is sought pending resolution of the waiver request.
 - *See* 47 C.F.R. 1.925; *see also First Report and Order*, FCC 00-209 para. 29.

Applying for Tribal Lands Bidding Credit

- Applicant indicates each market for which they seek tribal lands bidding credits on their long-form application (the Form 601) by its filing deadline.
- Applicants are allowed 180 calendar days to amend their long-forms and attach the required certifications.
- See 47 C.F.R. 1.2110(f)(3)(ii)

Required Certifications

■ **Tribal Government Certification**

1. It will allow the applicant to site facilities and provide service on its tribal land(s), in accordance with FCC rules;
2. It has not and will not enter into an exclusive contract with the applicant precluding entry by other carriers, and will not unreasonably discriminate against any carrier; and
3. Its tribal land is a qualifying tribal land as defined by the FCC rules, *i.e.*, areas that have a telephone penetration rate at or below 85 percent.
4. See 47 C.F.R. 1.2110(f)(3)(ii)(A)

Required Certifications (cont.)

■ **Applicant Certification**

1. It will consult with the tribal government about siting facilities and providing service on its land; and
2. It will comply with the special three-year buildout requirement for the tribal land
3. See 47 C.F.R. 1.2110(f)(3)(ii)(B)

Construction Requirement

- In order to verify compliance with the tribal lands buildout requirement, licensees are required to file a notification of construction (Via the Universal Licensing System).
- Must be filed no later than 15 days from the conclusion of the three-year buildout period.
- Must state that they have constructed and are operating a system that covers 75 percent of the population of the qualifying tribal land.
- See 47 C.F.R. 1.2110(f)(3)(vii)

Repayment

- If the buildout requirement is not met by the 3-year deadline or if the notification of construction is not filed, the licensee must repay the bidding credit amount plus interest.
- Repayment is due no later than 30 days after the 3-year buildout deadline date.
- Failure to repay will result in automatic termination of the license.
- See 47 C.F.R. 1.2110(f)(3)(viii)

Transfers and Assignments

- Transfers of Control, or assignment, of licenses is permitted.
- Obligations of the license automatically transfer to the transferee or, if a full assignment, the assignee.
- If partitioning a license with a TLBC, the tribal land must be "wholly contained" within one of the areas and the bidding credit goes with the area covering the tribal lands.
